Special and/or Sensitive Personal Data We Process

Purpose and Basis for Processing Personal Data

How Long We Retain Personal Data

NowOnline does not retain your personal data longer than strictly necessary to achieve the purposes for which your data is collected.

Sharing Personal Data with Third Parties

NowOnline only shares personal data with third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Cookies, or Similar Techniques, We Use

NowOnline uses functional, analytical, and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet, or smartphone when you first visit this website. NowOnline uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website function well and to optimize it. In addition, we place cookies that track your browsing behavior so that we can offer customized content and advertisements.

On your first visit to our website, we informed you about these cookies and asked for your consent to place them.

You can opt out of cookies by setting your internet browser so that it no longer stores cookies. Additionally, you can delete all information previously saved via the settings of your browser.

Viewing, Modifying, or Deleting Data

Please make your passport photo, MRZ (machine-readable zone, the strip with numbers at the bottom of the passport), passport number, and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.
